- 2. The Honourable High Court has very clearly defined time frame for action by residents / MC/DDA. Individuals will be responsible for taking action within time frame fixed by High Court. Noncompliance will be CONTEMPT OF THE COURT ORDER" against individual.
- 3. The time frame for action by individual residents / DDA/MC are summarized as follow:-

DDA	21 Jun 24 to 12 Sep 24 (12 weeks)	Upon receipts of such applications for regularization / compounding of existing construction from members of society, the DDA shall consider and dispose of the applications.
Flat owners /occupants	13 Sep 24 to 21 Nov24 (10 weeks)	The owners /occupiers of the respective flats shall take requisite steps for removing the unauthorized constructions / non-compoundable deviations in terms of the order of DDA with in a period of 10 weeks.
DDA	22 Nov 24 to 30 Jan 25 (10 weeks)	In case the unauthorized constructions / non-compoundable deviations existing in the flats are not removed by the respective owners / occupants with in period of 10 weeks of passing the order by DDA, the DDA shall take requisite action for removal of such unauthorized construction / deviation with in a period of 10 weeks.
