AGENDA POINTS FOR SPECIAL GENERAL BODY MEETING TO BE HELD ON 12th MARCH 2023

- 1. Further to our Call-up notice issued for SGM to be held at 10.30 am on Sunday the 12th March 2023 vide Letter no.09 dated 4th March 2023:-
- 2. The SGM is being called for decision of members on replacement / repair to the existing pipe lines which are passing through the shafts external to the buildings. There are a total of 144 shafts with 5 pipe lines in each shaft. These pipe lines are basically of Cast iron (CI) or Galvanized iron (G I) origin.
- 3. In the recent past there have been numerous instances of leakage in the pipe lines due to cracks / rusting due to ageing. The piece meal repair is not cost effective and is also functionally and aesthetically improper. This being, the MC has to call an SGM to take a decision as to whether the complete pipe lines should be changed in the whole of the complex or piece meal repair/ replacement are to be resorted to.
- 4. The House will also be requested to take decision on financing the project decided at during the deliberations of the SGM. The project is being classified under two options, viz:-

OPTION (1) APPROVAL FOR TURNKEY PROJECT FOR REPLACEMENT OF OLD CI/GI PIPES IN ALL THE 144 SHAFTS IN OUR COMPLEX AS A COMPOSITE WORK COSTING Rs 1.75 Cr PLUS –MINUS (+/-) Rs.25 LAKHS
